"The accused was found to be a member of the Ghazwa-e-Hind module, operated by Pakistan-based operatives, with the objective of radicalising impressionable youth for the establishment of Ghazwa-e-Hind over the Indian territory," the agency said. "Investigations revealed that Danish was the admin of a WhatsApp Group 'Ghazwa-e-Hind', created by a Pakistani national named Zain. He had added many Indians, Pakistanis, Bangladeshis... Yemeni nationals to the group with the aim of establishing sleeper cells in the country for carrying out terrorist activities," the agency said.

Further probe showed that various suspects involved in the case were in contact with Pakistan-based handlers and were involved in propagating the idea of Ghazwa-e-Hind, the NIA said.
